1. AVIATION PRODUCTS LIABILITY INSURANCE, for a Combined Single Limit (Bodily Injury/Property Damage) of USD 250,000,000 any one occurrence, and in the annual aggregate

2. AVIATION GROUNDING LIABILITY INSURANCE, for a Combined Single Limit (Bodily Injury/Property Damage) of USD 125,000,000 any one occurrence, and in the annual aggregate.

Coverages 1 and 2 are subject to an overall combined single limit (Bodily Injury/Property Damage) of USD 250,000,000 any one occurrence and in the annual aggregate.

3. AVIATION WORKING PARTIES LIABILITY / PREMISES AND HANGARKEEPERS LIABILITY INSURANCE, for a Combined Single Limit (Bodily Injury/Property Damage) of USD250,000,000 any one occurrence.

The above mentioned coverage is subject to the War Hi-jacking and Other Perils Exclusion Clause (Aviation) AVN 48B, but coverage in respect of War and Allied Risks is provided in accordance with the Extended Coverage Endorsement (AVN 52G) and is subject to an overall combined single sub-limit (Bodily Injury/Property Damage) of USD 250,000,000 any one occurrence and in the annual aggregate,

It is further certified that in connection with an Agreement (Contract # 1667) entered into between Dassault Aviation Business Services SA Switzerland and Rockwell Collins, Inc., Business and Regional Systems (the "Agreement"), the following insurance provisions shall apply to the extent of the insurance and indemnity obligations in the Agreement:-

1 Under the LEGAL LIABILITY Insurance

1.1 To include Rockwell Collins Inc., Business and Regional Systems as additional insured(s) for

their respective rights and interests (the “Additional Insured(s)”))

1.2 To waive all rights of subrogation against Rockwell Collins Inc. in respect of Hangarkeepers Liability.

1.3 The Insurance provided hereunder shall be primary and without right of contribution from any other insurance which may be available to the Additional Insured(s).

1.4 Except in respect of any provision for Cancellation or Automatic Termination specified in the Policy or any endorsement thereof, cover evidenced by this Certificate may only be cancelled or materially altered in a manner adverse to the Additional Insured(s) by the giving of not less than Thirty (30) days (but seven (7) days or such lesser period as may be customarily available in respect of War and Allied Perils) notice in writing. Notice shall be deemed to commence from the date such notice is given by the Insurers. Such notice will NOT, however, be given at normal expiry date of the Policy or any endorsement.

Subject to the terms, conditions, limitations, exclusions and cancellation provisions of the relative Insurances.
