Application for Name Change and Change of Work Scope BSL, FOCA Approval of Expositions

Dear Mr. Madignier

We acknowledge reception of your application for name change and change of work scope for the line station BSL, as well the related documentation.

Our review of the application package revealed no noncompliance's; however, some observations which will be covered with the conditions below, per article 145.B.35(2) of Commission Regulation (EU) No 1321/2014 Annex II (Part 145).

We have attached to this letter the FOCA approved DABS MOE edition M, revision 0 which will become effective as of October 1st, 2022, as well all related documents. The issue of the new certificate and terms of approval is planned for the end of week 38, with issue date October 1st, 2022.

Conditions:

- The name of TAG Maintenance Services SA will change September 30st, 2022, 24:00 o'clock to Dassault Aviation Business Services SA October 1st, 2022, 00:01 o'clock, the approval no. CH.145.0248 will remain the same.
- TMS to provide prior October 1st, 2022, a copy of the register of commerce, containing the new organisations name.
- DABS to provide not later than January 14th, 2023 all NDT related documents with new logo and organisations name, namely the written practice per EN 4179, NDT procedures and related forms.

- DABS to provide not later than January 14th, 2023 all low level procedures, forms, blue and red tags referenced to in the MOE as TAG xxxx with new logo and organisations name.
- For tools and equipment the FOCA accepts TMS (TAG) stickers and labels of calibration and preventive maintenance until next calibration and or preventive maintenance action.
- For maintenance projects commenced prior October 1st, 2022 and terminated after October 1st, 2022, the FOCA accepts the use of maintenance records, stamps and tags issued under the name of TAG Maintenance Services SA and if agreed with the customer; however, beginning October 1st, 2022 any release to service must be issued under Dassault Aviation Business Services SA.
- EASA Form 4, FOCA accepted senior management personnel under TAG Maintenance Services SA remain valid under Dassault Aviation Business Services SA.
- DABS may request a due date extension for the aforementioned due dates, provided an application is received by the FOCA 30 working days prior expiration of the due date and by providing a corrective action plan, documented evidence and a risk assessment.
